WHAT'S NEW THIS WEEK?

988 - Federal Suicide and Crisis Hotline Now Up and Running



https://988lifeline.org/ was officially launched on Saturday, July 16th across the nation as the new dialing code that will direct callers to the 988 Suicide and Crisis Hotline. People can dial or text to be connected to trained crisis counselors to provide comfort, support, and resources for those individuals going through a difficult time. If an individual prefers chatting, they can visit https://988lifeline.org/chat/ After answering a few questions, a crisis counselor will connect.

There will be a caring and compassionate person on the other end seeking to support anyone who may be feeling suicidal, or experiencing

a mental health, or substance use crisis. These trained counselors will help connect them to resources to help the individual in need navigate through their crisis. When someone in the state of Florida uses 988, they will be routed to one of 12 designated call centers based on their geography. **988** is a free resource to everyone and does not require any special codes when calling, chatting, or texting.

The official launch of 988 reminds us that now is as an important time as ever to ensure there is help that is easily accessible for people experiencing life's challenges. COVID-19 has exacerbated the need for a streamlined system of care that offers substantive assistance.

PROJECT/EMPLOYER LEARNING COLLABORATIVE (ELC) OPPORTUNITIES AVAILABLE TO OUR EMPLOYER MEMBERS

Tuesday, August 30, 2022, 10:00AM - 12:00PM - Mental Health/Substance Use (MH/SU) ELC

Our main employer contacts will soon receive an email with an invitation to participate in this ELC which will be held in-person in Tampa and virtually. Please note that if you intend to participate in person, seating at the Tampa location is extremely limited and will be accepted on a first come, first served basis. All other registrants are welcome to participate virtually. This kick-off meeting will ramp up implementation of the *Path Forward for Mental Health and Substance Use*. We will refresh meeting attendees on the five pillars of *The Path Forward*.



- Improve in-network access to MH/SU care providers
- Expand screening and testing for MH/SU conditions (measurement-based care)
- Expand MH/SU integration into primary care settings including pediatrics and OB/GYN (the collaborative care model),
- Improve tele-behavioral health access, quality, cost, and integration with primary care; and
- Resolve legacy mental health parity compliance issues.

We will solicit feedback from the attendees regarding the draft *Path Forward – Florida* action plan we have been developing. We will be hearing updates from around the state on activities that have already been initiated with employers to improve the system of care.

Attendees will learn about the best practice mental health workplace practices developed by Johns Hopkins Bloomberg School of Public Health which includes positive organizational culture, robust mental health benefits, healthy work environment, workplace policies and practices, employer-sponsored mental health resources, innovation, and leadership support.

We will also recognize Tommy Inzina, CEO of BayCare, with our "Healthcare Hero" award for his impactful work in mental health in the Tampa Bay area!
