Hospital Price Transparency – Getting to a Fair Price

This Tuesday, August 16th, was a busy day! We had a Board of Directors meeting and held an Employer Roundtable on Hospital Price Transparency. Thank you to Independent Colleges and Universities Benefits Association (ICUBA) for hosting and for handling all the technical aspects of the two meetings.

At the Board meeting, several decisions were made including a decision to enhance our capabilities in

health policy. We will be engaging with a consultant to help us expand our state health policy activity, increase awareness of the Florida Alliance with elected officials and other key stakeholders, and educate about the extreme burden Florida's employers are shouldering with high hospital pricing, being mindful of the important relationships we all have with the hospitals in Florida. That being said, **Florida is the third highest price state in the US for how much self-funded employers pay hospitals** for services as per the recent <u>RAND Hospital Price</u> <u>Transparency Study</u> at 345% of Medicare pricing.



We have no plans to put any policies or proposed legislation forward at this time – education and awareness are our focus. This is new territory for us, so we will proceed thoughtfully and carefully.

After the Board meeting, representatives from Brevard County Government, the City of Miami, ICUBA, Miami-Dade Public Schools, Orange County Public Schools, Orange County Government, The Mosaic Company, and Comcast NBCUniversal participated in an employer roundtable to learn how to use the <u>Hospital Value Dashboard (Sage Transparency)</u> and to discuss market and policy-based strategies that the Florida Alliance and the employer members can work on together. Key takeaways include:

- Create succinct messaging on this complex issue
- Educate the C-Suite of our employer members as soon as possible
- Work with the media to tell the employer side of the story
- Research what other states have done to curb hospital pricing
- Educate elected officials
- Increase the number of employers in the Florida Alliance membership because we need to have a critical mass of lives and dollars spent in order to influence change in each market

• Take charge of the hospital meetings and go into them with a fair price in mind, possibly using the methodology that was shared at the roundtable

Florida Alliance staff have been working with the Delivery and Payment Reform Strategy Group of the National Alliance to develop a playbook for all employers that lays out all the information shared in Tuesday's roundtable. We will share that playbook as soon as it is finalized and released.

A topic that came up on Tuesday was how few hospitals in Florida are complying with federal transparency laws. A very timely article came out the next day:

80% of Florida hospitals not complying with the federal price transparency law

A <u>new report</u> published by <u>PatientRightsAdvocate.org</u> found that most hospitals are withholding crucial information from patients and consumers, including employers, by not releasing their actual,



complete pricing data or by making the data difficult to access. Nearly 20 months since the hospital price transparency rule took effect, the analysis for the report suggests that the vast majority of hospitals remain noncompliant with the rule, and **some previously compliant removed pricing data from their files**. In addition, the data implies that lack of enforcement by the Department of Health and Human Services has led hospitals to continue to disregard the rule.

CDC's Updated COVID-19 Guidance: Next Steps for Business

Last week, the Centers for Disease Control and Prevention (CDC) updated its COVID-19 guidance to align with high levels of immunity and the availability of treatment and prevention tools that have made serious illness, hospitalization, and death less likely.



Updated recommendations include:

- People exposed to the virus no longer need to quarantine for 5-days but rather, they should wear a high-quality mask for 10 days and get tested on day 5.
- In most circumstances, companies are no longer recommended to test employees in order to screen for the virus.
- Social distancing is not universally required.
