Millions of Americans struggle with addiction as it continues to take a heavy toll on our communities. According to the CDC, over 107,000 people died from drug overdoses in 2021, the majority of them from fentanyl or another synthetic opioid. Alcohol-induced deaths rose to over 52,000 in 2021. COVID-19 has exacerbated the difficulties people experience, resulting in higher instances of substance misuse and addiction, anxiety, depression, suicidal ideation, and post-traumatic stress disorder. On the economic front, it is estimated that the addiction crisis costs around \$740 billion annually in lost work, health care, and engagement in the legal system. Employers are not helpless in assisting employees. Here are two toolkit offerings employers can use for implementation to better support their staff:

1. The Boston Medical Center offers a library of easy to access and adapt resources (<u>Supporting and Encouraging Employees | Boston Medical Center (bmc.org)</u>); and



2. The National Safety Council offers a toolkit on opioids and the workplace (Opioids at Work Employer Toolkit - National Safety Council (nsc.org))

In addition, employees should be reminded of the Substance Abuse and Mental Health Services Administration's (SAMHSA) National Helpline available to them, available in English and Spanish at 1-

800-662-4357 should they prefer to speak to someone privately about their struggles and identify treatment options and support groups. This helpline is different from 988, which is designed for people in the midst of a mental health crisis, which is also a valuable resource.


