### WHAT'S NEW THIS WEEK?

2023 Voice of the Purchaser Survey on Mental/Behavioral Health - Survey Deadline March 8



Mental health has been a key issue for all of our employer members, particularly with respect to historic issues with access to and quality of services provided. The Florida Alliance is a Regional Employer-Stakeholder Engagement Team (RESET) for The Path Forward for Mental Health and Substance Use, as you know. During our Employer Learning Collaborative on Mental Health and Substance Use, our RESET identified the need to develop an employer/healthcare purchaser survey so that we can identify areas of need and strategies to improve quality and access. When we reached out to the National Alliance to see if such a tool had been developed, they thought it was a great idea and engaged experts to develop a survey that could be rolled out nationally with all the RESETs and also with the coalitions not engaged with The Path Forward.

The Path Forward is now conducting a national survey of employers/healthcare purchasers to understand the perceived performance of services received from mental health service providers, including health plans and point solution providers.

### **Key Areas of the Survey:**

- Equitable Access
- Quality of Care
- Integration of Mental/Behavioral Health into Primary Care
- Workplace Mental Health Support



### Pharmacogenomics (PGx) Webinar Take-Aways

The National Alliance offered a complimentary webinar "Achieving Value through Health: Latest Evidence on Pharmacogenomics" on January 25.





Notes from the presentation are below:

Medications don't work for everyone. What if adverse events and subsequent ER visits were avoidable while improving treatment outcomes? PGx involves looking at DNA to predict how a patient will respond to specific drugs.

Medications may work differently in different patients in several ways, such as how quickly or slowly a patient metabolizes medication and/or an inability to metabolize a drug into the active ingredient. These variables could cause a drug not to be beneficial or could lead to an overdose.

Potential Benefits include:

- Improved medical decision-making
- Delivery of appropriate therapies that are tailored to a patient's sequence variants or genotype rather than the general population
- Avoidance of medications of lower efficacy
- Reduced exposure to medications that have the potential for greater toxicity, with resulting lower incidence of treatment-related side-effects and complications
