



Employer Member Benefit Resource – Employer Playbook on Biosimilars

Over the last several months, the National Alliance worked with three of its coalition members (Economic Alliance for Michigan, Florida Alliance for Healthcare Value and the Washington Health Alliance) to bring together several employers to participate in a Learning Collaborative on Biosimilars. Over the course of the project, this Employer Playbook was developed to support an employer's effort to consider adoption of biosimilars as part of their overall drug management strategy. The Playbook includes a checklist to address biosimilars and recommendations in five key areas: Plan Design, Formulary Design, Drug Access & Availability, and Sites of Care & Drug Availability.

Health Observances

March is National Colorectal Cancer Awareness Month



According to the Colorectal Cancer Alliance, one in 24 people will be diagnosed with colorectal cancer, or CRC, in their lifetime, and the American College of Gastroenterology states that CRC is one of the most preventable types of cancer. Every March, National Colorectal Cancer Awareness Month spotlights this disease and inspires more people to get checked starting at age 45. Two reasons why getting checked matters:

- Screening can find the warning signs of colon and rectal cancer, letting doctors take action to prevent the disease
- Screening can also find colorectal cancer early when treatment is most effective

ACTION ITEM: 2023 Voice of the Purchaser Survey on Mental/Behavioral Health - Survey Deadline March 15 (extended by a week)



As we shared last week and during last week's ELC session, the Path Forward is conducting an important national survey of employers/healthcare purchasers to understand the perceived performance of services received from mental health service providers, including health plans and point solution providers. For those of you who have already completed the survey, thank you!
