Opaque Conflicts of Interest Permeate Prescription Drug Benefits

Employers pay consulting firms to handle a straightforward job with their drug coverage – get the best deal possible for them. A STAT investigation shows that a largely hidden flow of money between major consulting conglomerates and PBMs compromises that relationship.

Depression and Suicide Risk in Adults

This week the U.S. Preventive Services Task Force released its final recommendation statements for

screening for anxiety in adults and screening for depression and suicide risk in adults. The taskforce recommended screening for anxiety in adults 64 years and younger, adding that the evidence was not sufficient to make a similar recommendation for adults 65 years of age and older. The taskforce recommended screening for depression in all adults but added that there was not enough evidence to make a similar recommendation regarding suicide screening.

This week the Florida Alliance signed on in support of a letter from The Leapfrog Group to the Office of the National Coordinator of Health Information Technology (ONC) to commend the ONC for their proposal to identify healthcare facilities by brick-and-mortar facility. Our organization agrees with Leapfrog that the continued

use of a single identifier for a broader health system that may include multiple individual facilities is misleading when it comes to interpreting quality and patient safety. We believe this change of identifiers would have a powerful and positive impact on healthcare transparency and quality of care.

FDA Advisers Endorse Targeting XBB Variant in New COVID Booster

On Thursday June 15, an expert Federal Drug Administration (FDA) panel unanimously recommended

updating the COVID booster for the fall. The group, citing the decreasing effectiveness of the current bivalent booster shot and the prevalence of a new strain of the virus, recommended the need to offer a newer booster to combat the COVID virus.

The group added that the single shot booster should focus on the XBB.1.5 variant, which is responsible for all infections in the US.
