




COVID-19 Update

Did you know that the State of **Florida has the highest rate of hospitalizations for COVID-19 in the United States** according to the CDC? The Florida Department of Health reported 23,960 new cases for the week of August 25, up from 7,320 the week of June 23 (click <u>HERE</u>). The latest CDC data shows that new hospital admissions due to COVID-19 in Florida increased from 951 on July 1 to 2,536 as of September 2. To go to the CDC COVID Data Tracker, click <u>HERE</u>).

This week, the CDC published updated guidelines for the FDA approved updated COVID-19 vaccine and manufacturers of the updated vaccine will make them available to the public this week.

The National Alliance of Healthcare Purchaser Coalitions released only an hour ago, a two-page guidance on this new guidelines based on feedback from their Coalition Health Advisory Council members. Karen van Caulil, Florida Alliance

President and CEO, and Rosa Novo, Florida Alliance Board Chair, have served on this advisory council for the past three years. **Click <u>HERE</u> for the infographic.**

Here is a summary of important information we have also gathered from the CDC and from the Health Action Alliance:

- The CDC recommends everyone six months and older get the updated vaccine as soon as possible. The latest mRNA vaccine is monovalent in nature, designed to protect against one variant (XBB1.5), a variant of Omicron that emerged earlier in the year.
- **Technically speaking, the shot is no longer a "booster."** Think of it like the annual flu shot that is updated annually to match the current strain of the disease.
- The updated vaccine is **administered in one shot**, **not a series** as it has in the past.
- Older adults and people with weakened immune systems are at highest risk for severe COVID-19 illness and should make sure they get the updated COVID-19 vaccine as soon as possible.
- Employers should check with their respective carrier to determine if the cost of the updated vaccine is covered for employees and covered members.
- The benefits to obtaining the vaccine continue to outweigh risks and vaccination is the best avenue for protection from severe illness and hospitalization.
- Employers **may want to consider incentives** to increase the percentage of people who obtain the updated vaccine, such as prizes, rewards, or modest financial incentives.
- Employers should also do their part in **helping people find a place to receive the updated vaccine**. It may not be as readily available as it has in the past because the organizations dispensing the vaccines are not receiving them free of charge any longer (we are no longer in a public health emergency). Vaccines.gov has a "Find COVID-19 Vaccines" that is being updated for the new shots. Click <u>HERE</u>. Please give it a few days to update since it currently has the availability of the old shots.
- Employers should also encourage their covered members to obtain the new immunizations for flu and RSV, as well, which can help prevent a "tripledemic" of respiratory infections.
- The CDC estimates that people should be able to start making appointments within the next week to obtain the updated vaccine.
- Free COVID-19 tests are still available at thousands of locations across the country.



On September 7 the President's Council of Advisors on Science and Technology issued a <u>report</u> recommending President Biden take actions to transform patient safety. **The patient safety problem is estimated to be the third leading cause of death in the country, exceeded only by**



cancer and heart disease but with no one individual or government agency responsible for solving it.

The Role of Employers in Addressing Quality Variation in Employer-Sponsored Health Insurance

The use of cost and quality of care data, in conjunction with novel analytical approaches, can assist employers in designing high-quality and economically efficient health benefits according to a new article published in the *New England Journal of Medicine (NEJM) Catalyst*. Variation in provider quality is a driver of poor health outcomes, missed opportunities for life-saving treatment, and unnecessary utilization, and has historically been very difficult to measure. **This article addresses how new data approaches are available to employers to evaluate and act on provider quality metrics**.



The authors used data from Embold Health, a Florida Alliance Affiliate Member, to show how employers can identify and match high-quality providers with covered members. The continued progress towards price and care transparency offers opportunities for employers to leverage their data to curate a provider network that provides high quality care at a fair

price. Provider quality can be integrated into network design as well as potentially incentivize covered members to choose the high-quality providers through low out-of-pocket payment options, ensuring employers can rein in costs while ensuring covered members receive clinically meaningful care.
