Employer Member Benefit: WEBINAR – Biomarker Testing – Tuesday, October 31, 1:00PM – 2:00PM

Biomarker testing is a necessary tool in advancing precision cancer treatment. According to a new



survey released by Cancer*Care*, a leading national cancer support organization, biomarker testing helped physicians tailor therapy for nearly all the respondent patients (93%) whose cancers were tested over the past three years. 20% of the patients surveyed were able to avoid unnecessary chemotherapy and/or radiation and 10% became eligible for a clinical trial.

Employer Member Benefit: WEBINAR – Cell and Gene Therapies – Tuesday, November 21, 11:00AM – 12NOON

Cell therapy aims to treat diseases by restoring or altering certain sets of cells or by using cells to carry a therapy through the body. With cell therapy, cells are cultivated or modified outside the body before being injected into the patient. The cells may originate from the patient or a donor. Gene therapy aims to treat diseases by replacing, inactivating, or introducing genes into cells – either inside the body or

outside the body. Some therapies are considered both cell and gene therapies. These therapies work by altering genes in specific types of cells and inserting them into the body.

Karen van Caulil will also moderate this next panel session. Join us to learn more about these leading edge treatments. **Karen's panel**



will include the Medical Director at Johnson & Johnson responsible for cell and gene therapies. He will explain in more detail than above how they work. Also joining the discussion will be an employer who is covering these therapies and found a payment solution that makes it more affordable than working through the health plan.

Benefits Nation event hosted by The Validation Institute in Houston.
We heard from our colleagues that Stephanie and Rosa both did a
fantastic job!

We are pleased to share Stephanie's presentation entitled "Making the Impossible Possible: How HR Can Be Healthcare Changemakers." Her presentation provided Gulf Marine Repair's historical benefits summary, their transition from fully insured to self-funded, cost-containment strategies, contracting with a transparent PBM, the use of a walk-on clinic, and their cost savings. Rosa's session focused on the importance of finding solutions platforms and direct contracting. Her message to employers was:

- Employers can no longer accept the status quo and offer off-the-shelf, already packaged solutions
- Employers have a fiduciary and ethical responsibility to explore alternative options and aggressive but fair direct contracting provides this solution
- No one understands your members' needs better than you do. Challenging your healthcare vendor, benefits consultants, providers, and partners will not only give you a lower cost per unit of service, but it will also send a message that employers want to be part of the solution.






Take time in November to educate employees and their families about:
