Employer Member Benefit: *Complimentary Webinar* – Hospital Cost Tool: Version 3 – Tuesday, January 9, 3:00PM ET



The National Academy for State Health Policy's (NASHP) interactive <u>Hospital Cost</u> <u>Tool</u> provides insights into hospital expenditures on patient care services, including labor costs over time, and other expenses not related to patient care that affect hospital operating performance. The tool also shows how these costs relate to both the hospital charges (list prices) and the actual prices paid by health plans.
