### Novavax COVID-19 Vaccine Authorized for Individuals 12 Years of Age and Older

In October 2023, the Food and Drug Administration amended the emergency use authorization (EUA) of Novavax COVID-19 Vaccine, Adjuvanted to include the 2023-2024 formula. This monovalent vaccine has been updated to include the recent strain of COVID-19. The Novavax COVID-19 Vaccine Adjuvanted (original monovalent) is no longer authorized for use in the U.S.



Novavax's COVID-19 vaccine is the only non-mRNA vaccine option for COVID. The vaccine has demonstrated a 78-90% efficacy in preventing mild, moderate, or severe COVID-19 in patients aged 12 and above and can be safely offered with the flu vaccine for added convenience.
