

### Sepsis Identified as a Major Factor Driving High-Cost Claims for Florida Alliance Employer Members

Our High-Cost Claims Workshop held on June 3 identified sepsis as a significant factor driving high-cost claims among our Employer Members. We learned from Workshop facilitator Dr. Christine Hale that some of the sepsis is brought into the hospital by a patient who already has an infection when they are admitted while some of the sepsis is hospital acquired. All workshop attendees agreed that the signs and symptoms of sepsis are not common knowledge, and more is needed to educate employees.

#### What is Sepsis?

Sepsis is a life-threatening emergency that happens when your body's response to an infection damages vital organs and often causes death. Like strokes or heart attacks, sepsis is a medical emergency that requires rapid diagnosis and treatment. It is important to look for a combination of warning signs of sepsis. Spotting these symptoms early could prevent the body from entering septic shock and could save a life.

## Employer Member Benefit: Resource – *Making Florida the National Leader for Mental Health and Well-Being*

In 2018, the Florida Chamber Foundation, part of the Florida Chamber of Commerce, released a report known as the *Florida 2030 Blueprint*, which outlines 39 goals within its Six Pillars Strategic Framework to grow Florida to a top 10 global economy by 2030.

A key pillar of the *Florida 2030 Blueprint* is to Champion Florida's Quality of Life and a central goal within this pillar is for Florida to be a top five state for overall well-being. As such, the Florida



Chamber and the Florida Chamber Foundation researchers are developing targeted strategies for improving mental health and reducing substance abuse with emphasis on opioid use disorders. This statewide report contains 25 actionable recommendations to make Florida the nation's leader in mental health care and outcomes, a key component to meeting the overall well-being goal.

One of the Employer-Facing Recommendations aimed at making a direct impact on improving the behavioral health of employees and their families is to partner with and leverage the work of existing national efforts, such as the Path Forward for Mental Health and Substance Use, for which the Florida Alliance is the Regional Employer-Stakeholder Engagement Team. As you probably know, the Path Forward initiative leverages the purchasing power of employers to radically improve mental health service delivery across the entire healthcare ecosystem.

### **Employer Member Benefit: Resource – Maternity Care Common Purchasing Agreement**

The U.S. is facing a crisis in maternity care outcomes, and women today are more likely to die from complications of childbirth than the previous generation. Moreover, pregnancy-related mortality rates are more than four times higher for native Hawaiian or Pacific Islander women and three times higher



for Black women. Lack of access to maternity care is exacerbating this crisis, with 36% of U.S. counties identified as maternity deserts (a region with limited maternity care services and/or providers) and a new report shows more than half of U.S. rural hospitals no longer offer birthing services.

The unacceptably poor quality, coordination, and equity of care are particularly impactful for employers. Because employer-sponsored insurance funds over half of all births

annually in the U.S., the actions employers take to address maternity care can help improve maternal and newborn outcomes for all populations, regardless of income, education, or employment status.

The Purchaser Business Group on Health (PBGH) recently released its <u>Maternity Care Common</u>

<u>Purchasing Agreement</u> which aims to help employers promote and implement both evidence-based and innovative practices to address the maternity care and birth equity crisis.
