
### Employer Member Benefit: "Pulse of the Purchaser" Florida Results on Obesity Management




Last week we shared the National Alliance of Healthcare Purchaser "Pulse of the Purchaser" national results. To see the report, click HERE.

We have the Florida results from the survey and will periodically share them by topic in the Weekly Bulletin. This week we are focusing on the questions in the survey related to obesity management strategies.

In the two charts below, you can see the responses of our FL Alliance Employer Members regarding their uptake of various obesity management strategies as well as what is being planned.







For lifestyle programs, bariatric surgery coverage, steerage to Centers of Excellence for individuals with a high level of obesity, and communications strategies to reduce bias and stigma, some of the respondents indicated a need for more information. For obesity drug coverage, some respondents wanted more information on limiting access to GLP-1s to specific populations and for coverage of compounded GLP-1s for obesity.

A reminder that we held an in-depth Employer Learning Collaborative (ELC) last year for Diabetes and Obesity. There are great resources on the webpage from the ELC that discuss all these strategies.

### **VALUE-BASED PURCHASING OF HEALTHCARE COURSE**

# Value-Based Purchasing of Healthcare – A Practical Course for Employers Seeking Greater Value from their Health Benefit Spending – Register today!

Value-Based Purchasing of Health care is a course designed for benefits professionals to introduce them to the principles and methods of advancing the value of the health benefits spend. The program encourages participants to think and act differently and culminates in each participant developing their own customized action plan for applying knowledge gained in the course to their current place of employment.



### What is covered in the curriculum?

- Introducing the need for and tools of value-based purchasing, including the role of regional coalitions and the National Alliance
- Driving value through transparency and primary care
- Payment reform and methods of promoting efficiency
- Strategies for advancing population health
- Managing pharmacy benefits and PBM contracts
- Advanced topics in medical and pharmaceutical benefits management
- Spotlight on key tools and resources available to employers

The course is an 8-week virtual, asynchronous course commencing on Monday, January 13, 2025.

Each week includes recorded presentations, required and supplemental reading, a moderated discussion board, and optional weekly Q&A and discussion.

The target audience for the course is any person in a benefits or wellness role at an employer or purchaser organization. The course is especially helpful for people who are less experienced or wish to update their knowledge. Participants should expect to spend 2-4 hours per week participating in the course.

Our newest faculty member is Dr. Christine Hale from Lockton. Dr. Hale has been consulting with us on managing high-cost claims, which will be her focus in the course.
