#### **ACTION ITEM**

New Project Opportunity - Making Direct Contracting Easier Survey – Deadline to respond extended to Monday, December 16



You may recall that in the Florida results from the National Alliance of Healthcare Purchaser Coalition's *Pulse of the Purchaser* Survey that was released this fall, there was great interest expressed by our Employer Members who responded to the survey in pursuing direct contracting as a strategy to drive value in their health plans. In response to that feedback, we have identified a potential solution that was brought to our attention by Jeff Hogan of Upside Health Advisors,

LLC. Jeff was the moderator of a panel at our Annual Conference in May 2024 on advanced primary care and is an adviser to a new initiative called OpenNetworks.

OpenNetworks is a direct contracting marketplace that is open to any healthcare purchaser seeking transparently priced healthcare services, and to any provider willing to deliver them. They have built a network platform that is designed for today's transparency demands and data-sharing needs. Purchasers can see real costs. There are no "favored nation" clauses. They have developed flexible contracting models and have simplified the process for direct contracting. They have also added the ability to curate networks to meet specific cost, quality, and geographic requirements.

OpenNetworks wants to expand to Florida. They have engaged with the Florida Alliance to explore this new approach, but before we move forward, we will need some baseline information from you and a better idea of your needs. We have created a survey to learn more about your experience and/or interest in direct contracting — or your lack of experience and/or interest — whatever the case may be!

For those interested in learning more about OpenNetworks, we will have a roundtable discussion the week of February 3 (date and location still to be determined).
