Direct Contracting Survey Responses Still Needed! Healthcare System Revenues Projected to Increase in 2025



Deloitte recently conducted a survey of 80 C-suite healthcare system executives identifying top trends expected to impact their strategies for 2025. 59% of the hospital CEOs who responded to the survey expect their hospital to have a positive industry outlook in 2025. 69% of the respondents are expecting an increase in operating revenue, and 71% are expecting increased operating profitability!

Employer Member Benefit: Mental Health Parity Compliance Employer Toolkit (Webinar) – Wednesday, January 29, 2:00PM – 3:00PM ET



The Florida Alliance will be hosting a webinar to review and disseminate the final Mental Health Parity Compliance Employer Toolkit that was developed in partnership with the National Alliance of Healthcare Purchaser Coalitions and the Bowman Family Foundation. This webinar will be held on Wednesday, January 29.

President and CEO Karen van Caulil along with Dr. Henry Harbin and Beth Ann Middlebrook, J.D. will be explaining the Mental Health Parity

Compliance Employer Toolkit which will greatly assist employers with how to work with their TPAs (and carve out mental health providers, if applicable) on ensuring appropriate analysis of their mental health data as it compares to their physical health data.

ICER: Assessment of Barriers to Fair Access – Final Report



On Thursday, December 19, 2024, ICER released the Assessment of Barriers to Fair Access Final Report. ICER has partnered with IQVIA, a healthcare data and analytics provider, to help gain insight into national level cost sharing and prior authorization metrics from real-world data claims. This partnership has allowed ICER to evaluate measures illustrating consumer accessibility for a subset of 11 drugs that have been in scope for the past two years in the

commercial line of business.

ICER has assessed how well major carriers' coverage policies for prescription drugs align with a set of fair access standards. ICER has defined concordance as the alignment of the coverage policy in four areas: (1) cost sharing to patients; (2) clinical eligibility; (3) step therapy policies; and (4) provider qualification restrictions.

Employer Member Benefit: Health Policy in Transit Policy Brief - End-of-Year Funding Bill and Next Steps

In December, Congress passed a Continuing Resolution and sent it to President Biden for signature. The legislation extended federal government funding through March 14, 2025. However, it does not contain many of the health policy reforms that were included in earlier versions of the bill.



The National Alliance along with key partners including the Florida Alliance will be working on getting the transformative PBM accountability provisions included in the next funding bill.
